NOTIFICATION

The matter regarding revamping the practical examination process and amendment in Assessment & Promotion Rules in connection with setting of practical question papers was placed in 1st Board meeting of 2024 held on 18-01-2024, under agenda item No. 10; and the Board discussed the agenda item in detail and appreciated the efforts of Chairman, PBTE & COE, PBTE for their unparalleled efforts for the revamping and improvement of examination system; especially the revamping of practical examination system in Punjab. The Board appreciated this continuous three years struggle and considered it to be the historic efforts in the history of PBTE. The Board acknowledged the completion of the first phase of the appointment of external examiners for DAE practical examination and finally approved the agenda item; the Board approved the proposal regarding amendment in clause 3.7 of DAE Assessment and Promotion Rules 2013, the detail of which is as under.

3.7 Distribution of marks for the practical component / training will be as under:

i) Sessional Part

60 % marks will be assigned to the work done during the session including operations, jobs, practical, note books, internal tests etc. These marks will be duly vetted by the Head of Department and Principal of the institution. Evaluation of sessional marks will be according to the following criteria:

ii) Final Part

40 % marks will be assigned to the final practical examination (to be conducted by the Board). For evaluation of marks, the practical subjects are divided into two groups i.e., category (A) and category (B) Evaluation procedure for these courses shall be as under:

Category "A": Shall comprise of those subjects having shop floor activity throughout the year including drawing subject e.g., Workshop Practice, Engg. Drawing, Projects, Estimates and visits etc. The external examiner will select comprehensive jobs based on practical as per question paper set by the Board or by himself and the students shall be assigned the task. The examiner will evaluate the candidates through viva voce on this task.

Category "B": Shall comprise of those subjects having demonstration / experimental activity e.g., Physics, Chemistry, Computer Application and Engineering science. The practical question paper shall be set by the Board or by the external examiner and besides serving this paper practical shall be assigned to the candidates. External evaluation shall be based on the experiment / practical to be carried out.

Note:

Final practical examination will be conducted jointly by an external examiner (to be appointed by the Board) and an internal examiner (to be deputed by the Principal of the Institute). The external examiner will award the marks. Division of marks will be as under:



Secrecy Section shall get set the practical papers for all subjects of all technologies of 1st year in accordance with the pattern provided by R&D section for 1st annual examination 2024 and onward. Later on, for getting set of practical papers of 2nd year in 1st annual examination 2025 and onward and 3rd year in 1st annual examination 2026 and onward, the same procedure shall be adopted by the Secrecy Section. It is clarified that the implementation of the decision of the Board regarding conduct of the practical of DAE stream by PBTE shall be implemented w.e.f. academic session 2023-24 for fresh students of DAE.
