NOTIFICATION

In pursuance of the notification issued by P-TEVTA vide communiqué No. TEVTA / Acad /Cur./6-138/ Matric-(Tech&Voc.) & in the light of the recommendation of The Committee of Chairmen and Director Technical Education (CCDTE) under agenda no. 09 in its 69th meeting and subsequent approval of the Inter Board Committee of Chairmen (IBCC) in its 176th meeting dated 13th-14th, July, 2023 regarding inclusion of the subject of Tarjuma-tul-Quran as a separate subject with 50 marks each, this office is hereby pleased to notify that same shall be considered part of Scheme of Studies of both Matric Vocational and Matric Technical with various specialization, for the Muslim students. It shall be implemented with effect from current academic session 2023-2024.

It is reiterated that in order to provide equal opportunity to the students of other religions; *Religious Education, in lieu of Islamiyat with 50 marks whereas Ethics in lieu of Tarjuma-tul-Quran with 50 marks, each shall be offered in the scheme of studies.

It is also clarified for the information of all concerned that this decision will be applicable only on fresh students of 1st year, admitted this year (2023) and not on students already promoted to 2nd year.

Under the power delegated by the Board vide notification No: PBTE/R&D/2020/90 dated 28-02-2020, the Chairman, PBTE has been pleased to adopt and approve the above mentioned decision for its implementation in PBTE w.e.f the academic session 2023-2024.

***Note:** In the light of decision of Punjab Boards Committee of Chairmen (PBCC), the Non-Muslim students will be awarded the same marks in the subject of Religious Education as of Ethics in case the books of Religious Education are not printed / provided by The Punjab Curriculum & Textbook Board Lahore. The obtained percentage marks of the subject of Islamiyat for the students of Matric Vocational (Hearing Impaired Group) will be replicated against the subject of Tarjma-tul-Quran.
